The purpose of this contest is to stack five (5) blocks of wood in vertical form within a four (4) minute time limit. Pre-registration for the event will be held at 8 AM on Friday, August 16, 2019 on the stage in front of the grandstand.

A one (1) minute warm-up to familiarize the contestant with the loader will be permitted. The contestant, on the signal of the Head Judge, will attempt to stack blocks of wood in the proper sequence. Time will be kept until each individual block is secured. The quickest time wins the contest. Time will end when the Head Judge signals that the blocks are secured. A maximum of 12 contestants will be permitted to compete. The decision of the head judge is final. All blocks will be supplied by the committee. Only experienced loader operators will be permitted to compete.

**There will be a \$10.00 entry fee to enter the contest.**
